The purpose of this Call for Quotations (CfQ) is the provision of a supply of environmental educational material in the form of four (4) different posters in two (2) sizes, published by the Environment and Resources Authority, to be used to raise environmental awareness.

The educational material aims at providing accurate and concise information about the local environment which is understandable to the lay person. Each different poster will be printed in two sizes, so that it can be used both for display purposes (ie the A2 size) and as an information sheet (i.e. the A4 size).

The material shall be disseminated during ERA activities as well as upon demand by interested individuals, institutions and the general public.

The paper used shall be Forest Stewardship Council (FSC) certified in line with ERA's overall goal to safeguard the environment.

We shall require the printing, packaging and delivery of four (4) different posters in two (2) sizes which shall be undertaken according to the specifications indicated below:
